



## PUBLIC NOTICE

### SANKET SUNSOL IMAGING SERVICES SUSPENDED

The Health Professions Council of Zambia (HPCZ) wishes to inform members of the public, healthcare providers, cooperating partners, insurers and all stakeholders that, pursuant to Section 49 of the Health Professions Act No. 17 of 2024, it has ordered the immediate suspension of Medical Imaging Services offered by Sanket Sunsol Imaging Services Limited, located at Plot No. 26 Kuomboka Drive, Parklands, Kitwe, Copperbelt Province.

The suspension follows an inspection (Clinical Audit) conducted by HPCZ on 3<sup>rd</sup> June 2026, which identified significant deficiencies relating to the quality, safety, governance and regulatory compliance of the facility's Medical Imaging Services.

Following the audit, HPCZ determined that the continued operation of these services poses a risk to patient safety and therefore requires immediate regulatory intervention pending implementation of corrective measures and verification of compliance.

The suspension applies to the following services:

1. Ultrasound Services;
2. General Radiography (X-Ray) Services;
3. Mammography Services;
4. Magnetic Resonance Imaging (MRI) Services; and
5. Computed Tomography (CT) Services.

Accordingly, Sanket Sunsol Imaging Services Limited has been directed to immediately cease providing, undertaking, interpreting, reporting, outsourcing, facilitating or otherwise offering any of the above Medical Imaging Services during the period of suspension.

The suspension shall remain in force until the facility has satisfactorily implemented the corrective measures required by HPCZ and compliance has been verified through a follow-up inspection. Stakeholders and members of the public shall be notified accordingly when this suspension is lifted.

Members of the public requiring Medical Imaging Services are advised to seek such services from appropriately licensed and operational health facilities.

HPCZ remains committed to safeguarding the public and ensuring that healthcare services in Zambia are delivered in accordance with applicable professional, ethical, quality and safety standards.
